### If you meet the account requirements,\*\* you receive the following checking account benefits:

- 3.00% APY for balances up to \$25,000.
- Range of 0.53%-3.00% APY for balances over \$25,000 (no cap)\*\*, 0.05% APY
  if all qualification requirements are not met.
- ATM usage SNB will automatically refund your account up to \$12.00 per statement cycle for ATM surcharge and foreign fees (up to \$6 in surcharge fees and \$6 in foreign fees). Fees will be credited to the account by the end of each statement cycle.

++Monthly is defined as three processing days prior to statement cycle date. Requirements are considered complete when the transactions have posted to the account. Pending or unprocessed transaction not posted during the current statement cycle will be credited in the following statement cycle.

Interest rates are paid using the average-daily-balance method. This method applies a periodic rate to the average daily balance in the account for the period. The average daily balance is calculated by adding the principal in the account for each day of the period and dividing that figure by the number of days in the period. Interest is compounded daily and credited on the last day of your statement cycle. Non-cash items (e.g. checks) you deposit into your account begin to earn interest on the business day we receive credit. Your interest rate and annual percentage yield may change. Fees could reduce earnings on your account.



<sup>\*\*</sup>Account requires minimum opening balance of \$50. For accounts that meet qualifications during the statement period, an interest rate of 296% will be paid on the entire balance with an Annual Percentage Yield of 3.00% if your average daily balance is \$25,000 or less. An interest rate of 0.25% will be paid only for that portion of your average daily balance that is greater than \$25,000. The APY for this tier will range from 0.53% to 3.00% depending on the balance in the account. This range is calculated using a hypothetical average balance of \$250,000. For accounts that do not meet these qualifications, 0.05% APY is paid on the entire average daily balance and you will not receive ATM fee refunds. Rate is effective 11/15/24.
